Enclosed is a roster of physicians and allied health professionals who are in good standing with no restrictions and are cooperating with the Medical Staff Bylaws and Rules and Regulations of Norman Regional Health System to maintain their current staff privileges. This letter and the roster list are considered primary source verification. Please note the Norman Regional Health System includes Norman Regional Hospital, Norman Regional HealthPlex and Norman Regional Moore. Practitioners credentialed with Norman Regional Health System are affiliated with all three facilities.

## **DEFINITION OF STATUS:**

Active	Active staff physicians may admit. They must admit or otherwise be involved in	า
Active	Active stail physicians may damin. They mast damin or otherwise be involved in	

the care and treatment of a minimum of twenty-six patients during their two-year reappointment period. (Emergency medicine physicians do not admit).

**Associate** The active affiliate category consists of those qualified physicians, oral/

maxillofacial surgeons, podiatrists and dentists who do not care for patients in the hospital setting, who limit their practice to ambulatory care, and who desire to be associated with, but do not intend to establish a practice at System

Hospitals.

**Consulting** This category is reserved for medical staff members who do not meet the

eligibility requirements for the active category. The practitioner must be

involved in 6 patient contacts per two year period, and may only admit patients of the active staff member for whom he/she is covering to the service of the

active staff member.

**Courtesy** This category consists of those qualified physicians and oral/maxillofacial

surgeons who are involved in at least five (5) and not more than twenty-five (25) patient contacts per two year appointment period. Courtesy staff members may

admit.

**Honorary** Not eligible to admit patients to the hospital or to exercise clinical

privileges.

<u>Provisional</u> Appointee is in the first year of their medical staff appointment. Provisional-

active staff appointees may admit. Provisional-consulting staff appointees may admit under an active staff physician name when covering for that active staff

physician.

**<u>Privileges Only</u>** Practitioner has clinical privileges only – is not a member of the medical

staff.

Allied Health Staff May not admit patients. May assist in patient care within the limits of

their skills and within the scope of their functions.
